
### **Active Inventory**

Versus last year, the total number of homes available this month is lower by 9 units or 8%. The total number of active inventory this April was 102 compared to 111 in April 2024. This month's total of 102 is lower than the previous month's total supply of available inventory of 106, a decrease of 4%.



### **Units Sold**

There was an increase in total units sold in April, with 68 sold this month in Perry Hall, Nottingham, and Northeastern Baltimore County. This month's total units sold was higher than at this time last year.



### **Median Sale Price**

Last April, the median sale price for Perry Hall, Nottingham, and Northeastern Baltimore County Homes was \$382,000. This April, the median sale price was \$389,995, an increase of 2% or \$7,995 compared to last year. The current median sold price is 10% lower than in March.

Median sale price is the middle sale price in a given month. The same number of properties are above & below the median.

## **New Listings & Current Contracts**

This month there were 81 homes newly listed for sale in Perry Hall, Nottingham, and Northeastern Baltimore County compared to 102 in April 2024, a decrease of 21%. There were 73 current contracts pending sale this April compared to 89 a year ago. The number of current contracts is 18% lower than last April.

### Months of Supply

In April, there was 1.5 months of supply available in Perry Hall, Nottingham, and Northeastern Baltimore County, compared to 1.9 in April 2024. That is a decrease of 19% versus a year ago.

Months of supply is calculated by dividing current inventory by current sales. It indicates how many months would be needed to sell all of the inventory available at the current rate of demand.



# Sale Price to List Price Ratio

In April, the average sale price in Perry Hall, Nottingham, and Northeastern Baltimore County was 101.3% of the average list price, which is similar compared to a year ago.

## **Days On Market**

This month, the average number of days on market was 31, higher than the average last year, which was 22, an increase of 41%.
