



Active Inventory

Versus last year, the total number of homes available this month is higher by 31 units or 100%. The total number of active inventory this April was 62 compared to 31 in April 2024. Median sale price is the middle sale price in a given month. The same number of properties are above & below the median.







New Listings & Current Contracts


This month there were 63 homes newly listed for sale in Town of Herndon and North Herndon compared to 46 in April 2024, an increase of 37%. There were 45 current contracts pending sale this April compared to 47 a year ago. The number of current contracts is 4% lower than last April.



Months of Supply

In April, there was 1.4 months of supply available in Town of Herndon and North Herndon, compared to 0.9 in April 2024. That is an increase of 64% versus a year ago.

Months of supply is calculated by dividing current inventory by current sales. It indicates how many months would be needed to sell all of the inventory available at the current rate of demand.



Sale Price to List Price Ratio

In April, the average sale price in Town of Herndon and North Herndon was 101.7% of the average list price, which is 1.5% lower than at this time last year.

Days On Market

This month, the average number of days on market was 9, higher than the average last year, which was 8, an increase of 13%.
